Bourns® Model SRF1260 and SRF1280 Series Dual-Winding Shielded Power Inductors

Implementation of Multiple Changes

Riverside California — July 7, 2022 — In order to support our fast-growing demand and provide maximum flexibility to customers, Bourns will begin implementing several changes to improve the production efficiency and material sourcing lead time for the Model <u>SRF1260</u> and <u>SRF1280</u> Series Dual-Winding Shielded Power Inductors.

1) Several manufacturing procedures will be changed from a manual or semi-automated process to a fully-automated process. These changes should improve production efficiency, product quality and reliability. To accomplish these process changes, the design of the inductor shield and mounting base will be modified as shown below.

Change to inductor shield: Reduced wall thickness at the lower portion of the shield.

Existing Shield	Revised Shield
	Reduced wall thickness at the lower portion of shield (4 sides)

Change to mounting base: Added retainer wall.

Existing Mounting Base	Revised Mounting Base
	Added retainer wall (4 places)

Users should verify that the described changes will not impact the performance of the product in their specific applications.

2) Certain properties of the ferrite core will change. The material characteristics of the revised core are compared to the characteristics of the existing core in the following table:

Core Material Characteristics	Existing Core	Revised Core
Initial Permeability	2400	1500
Saturation Flux Density (mT)	510	490
Curie Temperature (°C)	≥ 215	≥ 220

The fit and function of the affected models will remain the same. The form of the affected models will change slightly due to the changes described above. The quality and reliability of the affected models should be improved. Traceability will be maintained through lot code and date code.

Samples built with the above changes are available on request. Bourns recommends that customers test the affected part number(s) in their specific applications for verification of satisfactory performance.

Implementation dates are as follows:

Date that manufacturing of existing product design and production process will cease: **September 17, 2022**Date that deliveries of products manufactured with revised design and production process will begin: **September 18, 2022**First date code using the above changes: **2238**
