Obsolete the 206403-x seals and supersede them with the 2267473-x seals. The seal material is changing from a light gray color nitrile rubber on the 206403 which is not EU 2015/863 (RoHS 2019) compliant to a black color nitrile rubber on the 2267473 which is RoHS 2019 compliant.
