1. General description

The 74HC4075; 74HCT4075 is a triple 3-input OR gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of V_{CC} .

 - For 74HC4075: CMOS level
 - For 74HCT4075: TTL level




Fig. 1. Logic symbol




Fig. 2. IEC logic symbol





Fig. 3. Logic diagram (one gate)






Fig. 5. Test circuit for measuring switching times




Fig. 6. Package outline SOT108-1 (SO14)
