



## PRODUCT END-OF-LIFE NOTICE

IQS211A-zzzzzzzz-TSR

### 1 Azoteq Product End-of-Life Policy

Azoteq appreciates that our customers often have long product life cycles. As Azoteq values our customers' needs, we try to keep older products in production for as long as possible. There is however situation when product obsolescence cannot be avoided.

When Azoteq determines to make a product obsolete or End of Life (EOL) the only formal notification to be provided will be this End Of Life Notice, indicating the affected products and time periods that may be applicable.

The notice will be distributed to selected customers, official distributors, and representatives and will be made available on the Azoteq website ([www.azoteq.com](http://www.azoteq.com)).

Azoteq aims to make available and identify replacement or alternative products in the EOL notifications when at all possible.

When an EOL notice has been given the typical time for customers to place final orders is six months from the date of customer EOL notification\*. Unfortunately, due to circumstances beyond our control, following the global capacity and shortage constraints we are facing we have no alternative but to enforce this EOL with immediate effect.

Fortunately, we have 2<sup>nd</sup> sourced the IQS211A-zzzzzzzz-TSR from a different foundry, even though it is a pin-to-pin compatible in fit, form and function, re-qualifying is not necessary, we do however recommend re-testing the IQS211B-zzzzzzzz-TSR, see IQS211A/B declaration for details regarding the additional fabrication (2<sup>nd</sup> sourcing) of the IQS211B-zzzzzzzz-TSR.

The time periods indicated by the EOL Product list below must be considered as the dates applicable to each individual product. This may vary from the above due to circumstances surrounding a specific product.
