## 1. General description

The 74CB3Q3257-Q100 is a quad high-bandwidth single-pole, double-throw FET bus switch. The device features one select input (S) and one output enable input ( $\overline{OE}$ ). The switch is disabled when the  $\overline{OE}$  input is HIGH. An internal charge-pump increases the gate voltage of the NMOS pass transistor. The result is improved R<sub>ON</sub> and R<sub>ON(flat)</sub> performance and the ability to switch 5 V signals when V<sub>CC</sub> = 3.3 V.

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 3) and is suitable for use in automotive applications.











Fig. 7. The data input (nA or nBn) to output (nBn or nA) propagation delays










Fig. 10. Package outline SOT403-1 (TSSOP16)
