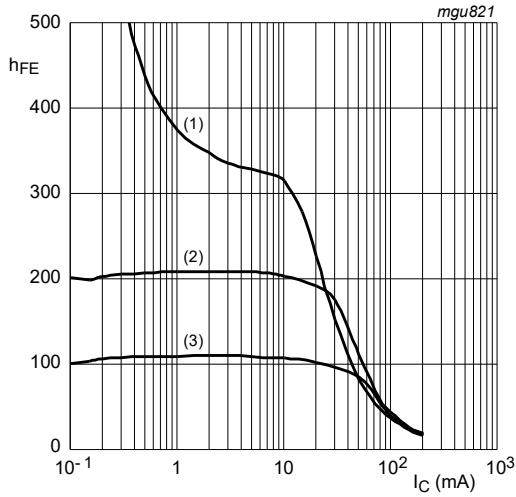

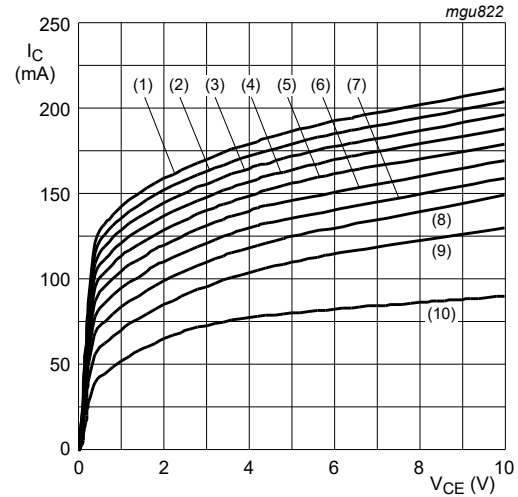

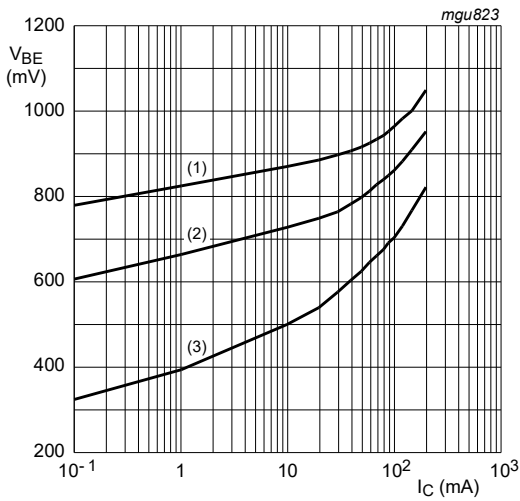

**Fig. 1. DC current gain as a function of collector current; typical values**



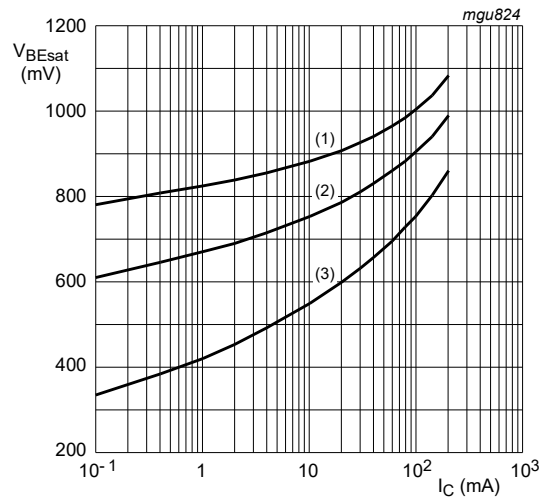

**Fig. 2. Collector current as a function of collector-emitter voltage; typical values**



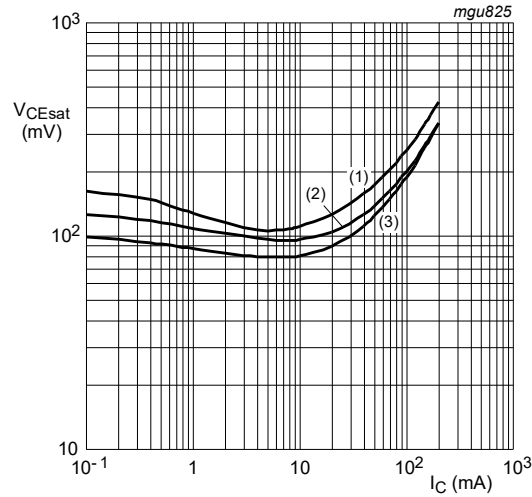

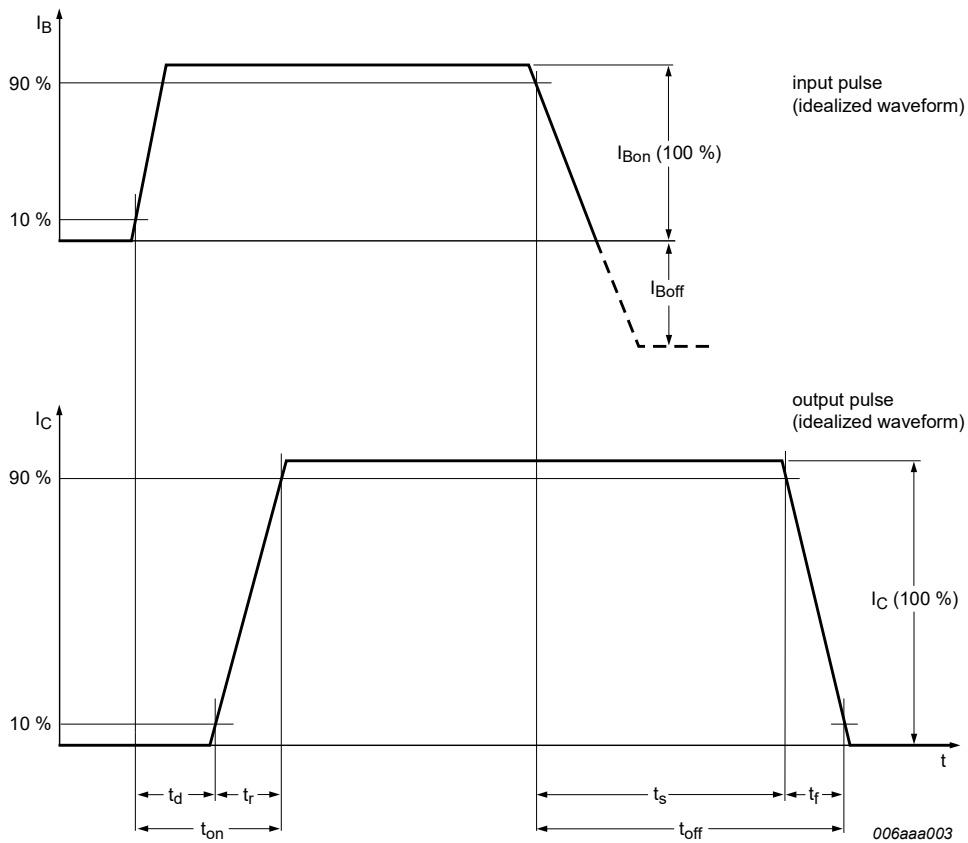


Fig. 6. Switching time definition

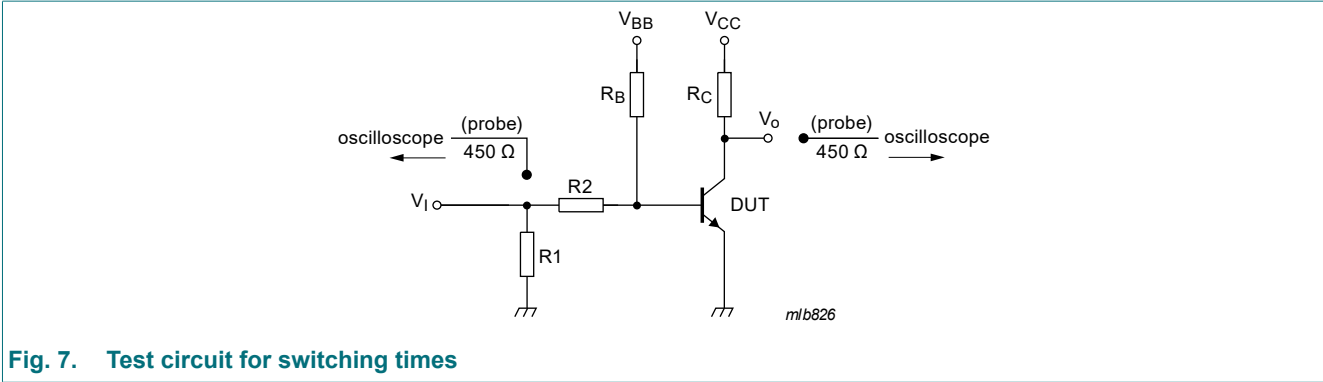


Fig. 7. Test circuit for switching times

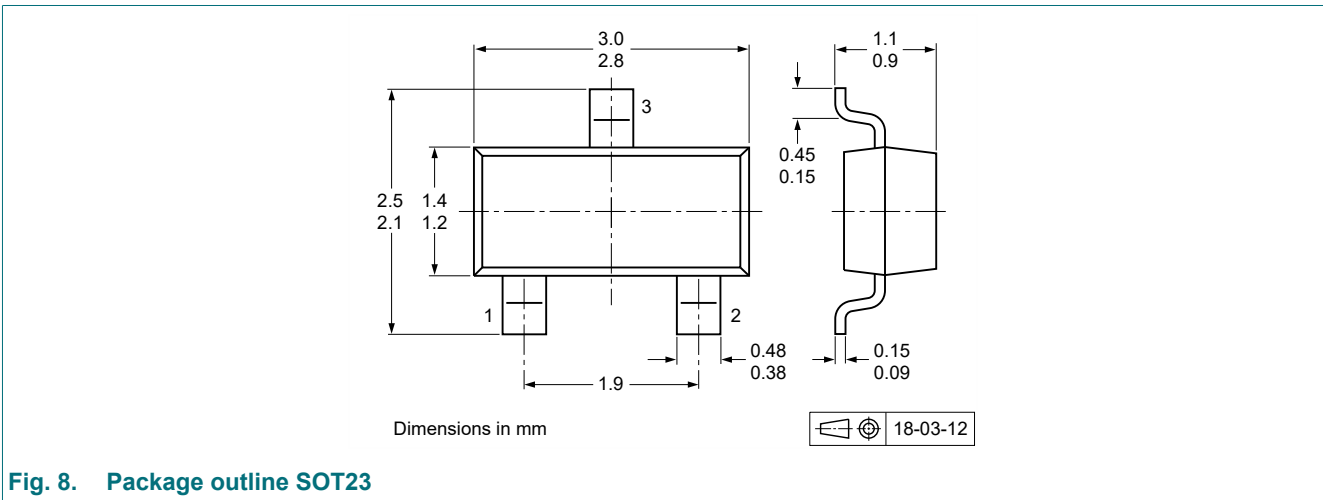


Fig. 8. Package outline SOT23
