
**Fig. 1 Typical Output Characteristics**




**Fig.2 Transfer Characteristic**




**Fig.3  $R_{DSON}$ - $V_{GS}$**




**Fig.4  $R_{DS(ON)}$ - $I_D$**

Fig.7 Normalized Threshold Voltage




Fig.8 Normalized On Resistance Characteristics




Fig.9 IS-VSD




Fig.10 Drain Current





Fig.11 PD Dissipation

Fig.12 Safe Operation Area





Fig.13 Normalized Transient Thermal Impedance
