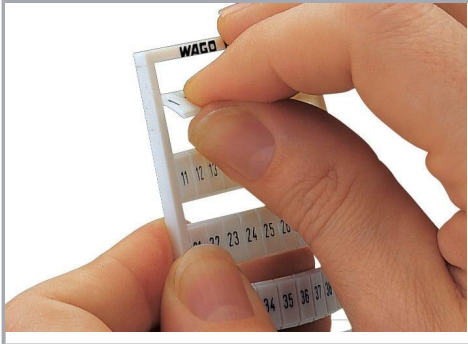

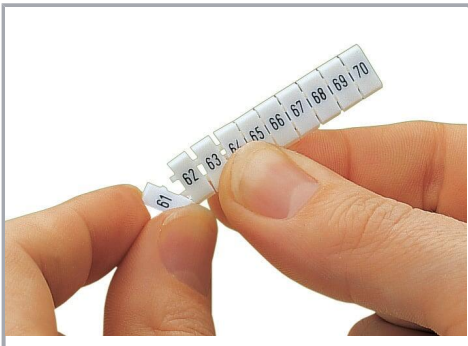

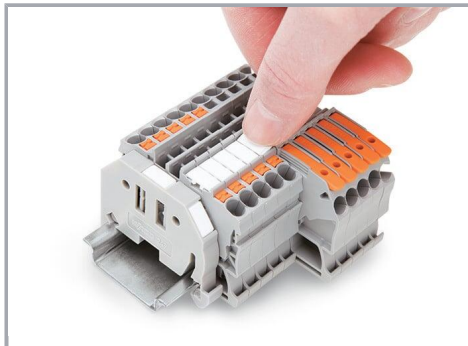
Separating a strip from the WMB or WMB marker card.

Separating an individual marker from the WMB marker strip – for larger terminal blocks.



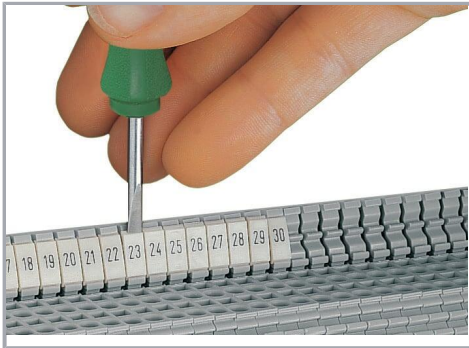

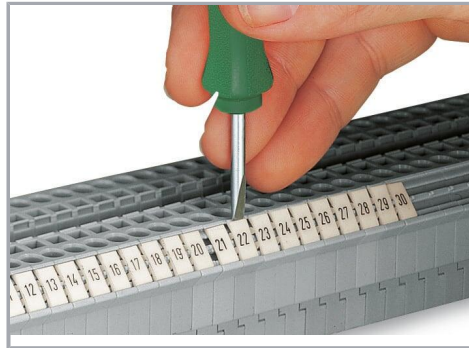
